Call Meeting to order

- Joe Casciano, Chairman of MARRC, called the meeting to order at 10:00 am.

Opening Remarks

Consent for the Participation

- Richard Waller Imperial Oil, motioned to consent for the participation and vote of those MARRC members who are attending the meeting by teleconference. Manny Micklash, Valvoline Canada Ltd. seconded. The motion carried.
- Lutz Ehrentraut, Secretary-Treasurer, confirmed that a quorum of the 203 Members were represented comprised of 9 Members in attendance in person and 7 Members by proxy for a total of 16.

Adoption of Agenda

- Richard Waller, Imperial Oil motioned that the Agenda be adopted as circulated. Manny Micklash, Valvoline Canada Ltd. seconded the motion. The motion carried.

Adoption of Minutes of previous Annual General Meeting

- Richard Waller of Imperial Oil motioned and Manny Micklash, Valvoline Canada Ltd. seconded that the Minutes of the 23rd Annual General Meeting of MARRC of April 29, 2020 be adopted as presented. The motion carried.

Adoption of the 2020 Audited Financial Statements

- Richard Waller of Imperial Oil motioned that the Audited Financial Statements for 2020 be received as presented., and Manny Micklash, Valvoline Canada Ltd. seconded the motion. The motion carried.

Appointment of Auditors for 2021

- Richard Waller of Imperial Oil motioned that PricewaterhouseCoopers, chartered accountants, be appointed auditors of the corporation for the fiscal year to end on December 31, 2020. Manny Micklash, Valvoline Canada Ltd seconded the motion. The motion carried.

Election of Board of Directors

- The Chairman explained that the terms of two of MARRC's five Directors would expire as of today's meeting. Those Directors were:
